DUAL: Dichotomies in Urban Agendas and Logics

What does it mean to engage critically with the theme of the city – or, more broadly, with urban space? Can we still consider this a well-defined field of inquiry, or does it continue to raise unsolved issues, contested practices, and discursive tensions that demand further problematization?

As we know, urban environments are **spaces of contradiction**: they are centres of wealth and poverty, innovation and tradition, community and isolation. From the bustling metropolis to the fragmented suburb, urban life is shaped by tensions that often appear as dichotomies: public vs. private, inclusion vs. exclusion, permanence vs. transformation, visibility vs. invisibility. These oppositions do not merely describe urban phenomena – they shape the material, social, political, and symbolic structures through which the urban is produced, inhabited, and interpreted. To read the city through dichotomies is therefore not to simplify it, but to open a critical lens on its layered complexities and contradictions.

Moreover, urban areas play a **central role in the European Union's policy agenda**. On one hand cities are at the forefront of challenges such as climate change, migration, digital transformation, and social inequality; on the other hand, they are also engines of innovation, economic growth, and cultural diversity. The **EU's Urban Agenda** and initiatives like the **New European Bauhaus** highlight the need for integrated, inclusive, and sustainable approaches to urban development. Indeed, investigating the contradictions within cities is not only intellectually vital but also politically and socially urgent, especially in the context of the EU's vision for a greener, fairer, and more resilient future.

DUAL - Aurora Academic Conference invites **university students**, **PhD students** and **researchers** from **all disciplines** to explore how these dualities emerge, overlap, and evolve within urban contexts. This **transdisciplinary conference** aims to foster dialogue across fields and methodologies, offering fresh perspectives on how cities are studied, understood, and experienced.

The conference is organised within the framework of the project **AURORA2030** and represents a continuation of the work begun as part of the course **Challenges in Europe** (April-June 2025).

Center - Periphery, Tradition – Innovation, Formal - Informal, Mobility - Immobility, Nature – Artificial, Growth - Decline, Safety - Surveillance, Belonging - Alienation, Open - Closed, Local - Global, Work – Leisure, Visible - Invisible, Production - Engendering, Private - Public.

We welcome **creative interpretations of "dichotomy"** and encourage proposals that challenge, subvert, or reinterpret this concept.

Language: the requested language of the conference is **English**. Please submit an abstract in English, for the sake of effective circulation.
